This year's theme, Equity in infrastructure, focused on the importance of partnering with small and diverse businesses to advance equity across infrastructure projects as well as understanding market conditions that impact the success of contracting in general, including projects supported through the Infrastructure Investment and Jobs Act (IIJA).
